*How Has a Mouse Helped You – Or Someone You Know?*  
National Student Biomedical Research Competition

Student Packet – Contest Explanation, Official Rules & Details

This contest asks students to develop a creative, educational and informative video essay to explain how they, a family member, friend, or pet, have benefited from medical discoveries made possible thanks to work conducted with mice in biomedical research.

This contest will provide students with opportunities to earn cash awards in response to how animals in research have helped the lives of people and/or animals.

This contest is open to all legal residents of the United States or District of Columbia who are registered students in grades 5 – 8 (Level 1) or grades 9-12 (Level 2). Every student is eligible: public, parochial, private/independent, home-school.

The 2017 Celebrate the Mouse Biomedical Research Video Essay Contest ("Contest") begins September 1, 2017 at 12:00:01 AM Central Standard Time ("CST"), and ends March 15, 2018 at 11:59:59 PM CST ("Contest Period").

***The Challenge***

Create an original video essay explaining/showing how you, a family member, friend, or pet, have been helped by medical advances made in biomedical research studies conducted with a mouse.

The Video Essay must include the following:

- A description of the role a mouse played in discovering or perfecting the surgical procedure, medication, or treatment method used to help the individual or animal; or, how a mouse was used in developing the detection technique used to identify the disease or condition.
- The name(s) of researcher(s) who worked with the mice to achieve the medical discovery.
- The date the medical advancement was achieved.

### ***To Be Successful***

- You must show that you understand the topic and present it, in video format, with originality, creativity and clarity. Judging is based on (a) creativity and originality including use of required elements (b) the quality of the information you provide, (c) how well your video submission exemplifies the actual biomedical research, (d) the power of your work and (e) overall impression. Create your entry so that it engages and captures the attention of your audience.

### ***Contest Rules Summary (See Official Rules for Details)***

1. Entrants must be legal residents of the United States or District of Columbia and a registered full-time student in grades 5 through 12.
2. Students must be 18 years of age or older, OR have parent or guardian's written permission to participate.
3. Video Essay may not exceed five (5) minutes in play length including credits.
4. Video Essay must be the fully original work of the student submitting the Video Essay.
5. Video Essays must be respectful of corporate or other identities and logos.
6. Video Essays must not contain messages, words, or images that are inappropriate for viewers as determined by the judges.
7. The Video Essay may not include trademarks, logos, or copyrighted material not owned or created by student or used without permission (such as company names, music, photographs, works of art, or images published on or in websites, television, movies, or other media).
8. A list of sources used to cite facts shall be listed, (preferably in MLA format) within the credit section of the Video Essay submission. Wikipedia may not be used as a source.

9. Video Essays **MUST** be submitted in one of the following formats:
  - a. .mov
  - b. .mp4
  - c. .wmv
10. Only one Video Essay entry per student.
11. All submissions become the property of the AALAS Foundation and may be used to promote the importance and benefits of animals in research or as determined by the AALAS Foundation.
  - a. 12. By participating in this contest, you are agreeing that decisions made by the judges of the "2017 Celebrate the Mouse Biomedical Research Video Essay" are deemed final.

13. There is no fee for entering the contest.

**Submissions:**

- **There may not be anything in the Video Essay itself that specifically identifies the student or their school. This information should only be contained on your completed Online Entry Form.**
- **Step 1:** Complete and submit the Online Entry Form.
  - You will need to include the following information on the Online Entry Form
    - Your Name
    - Your Registered School Name
    - Your Registered Teacher Name
    - The Title of Your Entry
    - Your Email Address
    - Your Phone Number
- **Step 2:** Upon completion of the Online Entry Form you will receive an email with the following information:
  - Your Unique Entry Registration Number. This number is very important and will be needed when submitting your final video essay entry.
  - Video Submission Form
    - This form will need to be completed and emailed back, with appropriate signatures, to [foundation@aalas.org](mailto:foundation@aalas.org) no later than December 31, 2017.
    - **Entrants not submitting the Video Submission Form will be disqualified from the contest.**
- **Step 3: Complete the Video Essay Submission Form.** Be sure that:
  - The title on the form is the same as the title of the submitted Video Essay.
  - The information is complete and legible.
  - The completed form is signed by a supervising teacher, guidance counselor, principal, or other school official in which the student is registered.
  - The completed form is signed by the student (if 18 or older) or by the student and the student's parent or guardian (if 17 or younger) as indicated.

- **Step 4: Create Your Video Essay.** You should create an original creative, educational and informative Video Essay, maximum running time of 5 minutes, to explain how you, a family member, friend, or pet, have benefited from medical discoveries made possible thanks to work conducted with mice in biomedical research. Your Video Essay must include a description of:

- The role a mouse played in discovering or perfecting the surgical procedure, medication, or treatment method used to help the individual or animal; or, how a mouse was used in developing the detection technique used to identify the disease or condition
  - The name(s) of researcher(s) who worked with the mice to achieve the medical discovery
  - The date the medical advancement in research was achieved.
  - A list of sources used to cite facts should be listed, (preferably in MLA format) within the credit section of the video submission.
- **Step 5: Submit Your Video either by Mail or Email.**

- **Videos and supporting documentation must be received by 11:59 pm CST, December 31<sup>st</sup>, 2017.**
- Receipt of submission will be acknowledged to the contact email address provided for the student 18 years of age or older, or the supervising teacher and/or student’s parent or guardian.

## **Prizes**

First, Second and Third Place Winners will be selected by an AALAS Foundation Judge from the two student Contest categories:

1. 5<sup>th</sup> through 8<sup>th</sup> Grade Student Category
  2. 9<sup>th</sup> through 12<sup>th</sup> Grade Student Category.

The first 200 eligible student entrants will receive a free “Animal Roles in Medical Discoveries” poster and a free “Celebrate the Mouse” lapel pin.

**THE “2017 CELEBRATE THE MOUSE BIOMEDICAL RESEARCH VIDEO ESSAY CONTEST” IS A SKILL CONTEST OPEN ONLY TO LEGAL RESIDENTS OF THE 50 UNITED STATES OR THE DISTRICT OF COLUMBIA WHO ARE REGISTERED STUDENTS IN GRADES 5-8 (LEVEL 1) OR GRADES 9-12 (LEVEL 2).**

**NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN THIS CONTEST.**

**Contest Dates:** The 2017 Celebrate the Mouse Biomedical Research Video Essay Contest ("Contest") begins September 1, 2017 at 12:00:01 AM Central Standard Time ("CST"), and ends March 15, 2018 at 11:59:59 PM CST ("Contest Period"). **Contest Entity:** AALAS Foundation, 9190 Crestwyn Hills Drive, Memphis, TN 38125 "Sponsor".

**Eligibility:** Submitting a Video Essay in this Contest is open only to students who, as of date of entry are legal residents of one of the fifty (50) United States or the District of Columbia, and are registered students in grades 5 through 12. Employees, officers, directors and their immediate family members of the Contest Entity are not eligible to enter. For purposes of this Contest, "immediate family members" means parents, spouses, children, siblings, in-laws, grandmother, or grandfather.

**The Video Essay, Video Submission Form, all Photo and Video Release Forms and supporting documentation must be received by Sponsor by 11:59 pm CST, December 31<sup>st</sup>, 2017.**

- Receipt of a submission will be acknowledged to the contact email address provided for the student 18 years of age or older, or the supervising teacher and/or student’s parent or guardian.

A student may not enter more than one Video Essay in the Contest.

**Technical/Creative/Legal Requirements for the Contest Entries:**

- *Video Essay Running Time:* 5 minutes maximum, including any credits. Video Essay submissions longer than 5 minutes may be disqualified at discretion of Sponsor.
- *Language:* English
- *Creative Requirements:* In addition to the technical requirements, the following creative elements are a requirement of entry and must be included in a Video Essay Submission:
  - The role a mouse played in discovering or perfecting the surgical procedure, medication, or treatment method used to help the individual or animal; or, how a mouse was used in developing the detection technique used to identify the disease or condition
  - The name(s) of researcher(s) who worked with the mice to achieve the medical discovery
  - The date the medical advancement in research was achieved.
- A list of sources used to cite facts must be listed, (preferably in MLA format) within the credit section of the Video Essay submission. Wikipedia may not be used as a source.
- A Video Essay submissions may not:

- include trademarks, logos, or copyrighted material not owned or created by entrant or used without permission (such as company names, music, photographs, works of art, or images published on or in websites, television, movies, or other media);
- use individuals' names, in whole or in part (including the entrant's last name) without permission;
- refer to public figures;
- contain profanity, pornographic, or sexual content, content promoting alcohol, illegal drugs, tobacco, hateful content of any kind (including racism, sexism, etc.), or any other offensive, obscene, or inappropriate content as determined by Sponsor;
- defame, misrepresent, or contain disparaging remarks about people or companies, including, but not limited to the Sponsor;
- promote a political agenda regardless of the political affiliation;
- contain materials embodying the names, likenesses, photographs, or other identifying elements of any person, living, or dead without appropriate permission.

**Sponsor and/or their designated representatives, will review all Video Essay Submissions received during the Video Essay Submission Period and will only post those Video Essay Submissions on the Contest Web Site located at <https://tinyurl.com/Celebrate-Mouse-Entries> that conform to these Official Rules and the Terms of Use and Code of Conduct (collectively, the "Official Rules"), as determined by the Sponsor in its sole discretion ("Eligible Video Essay Submissions").** Entries that do not comply with these Official Rules, as determined in Sponsor's sole discretion, will be disqualified from the Contest. Decisions of the Sponsor are final and binding.

**Entry Terms:** Void where prohibited. By entering, entrant or their parent or guardian warrant that entrant's idea and Video Essay submission and all elements thereof satisfy the Terms and Conditions of the Contest including, without limitation, warranting that the Video Essay Submission:

- i. **is the original work of the entrant;**
- ii. **has not previously been published or won an award or prize of any kind;**
- iii. **does not infringe or violate the rights of any third party, including but not limited to, copyrights, trademarks, patents, trade secrets, logos, contract and licensing rights, rights of publicity or privacy, moral rights, or any other intellectual property rights;**
- iv. **is not subject to any third party agreements, and that the Sponsor will not be required to pay or incur any sums to any person or entity as a result of their use, exhibition or exploitation of the idea or video or elements therein;**
- v. **does not contain any content that is likely to be considered offensive by Sponsor or could adversely affect the name, reputation, or goodwill of the Sponsor.**

Entries may only be submitted by an individual student. Group entries will not be accepted (e.g., although different individuals might have taken part in the making of a Video Essay Submission, and more than one individual may appear in the Video Essay Submission, only one individual may be considered to have produced and submitted the Video Essay Submission). A person 17 years of age or younger (18 years of age or younger in Alabama and Nebraska) may not submit a Video Essay Submission without their parents or guardian's signed permission. By entering the Contest, each entrant represents and warrants that he or she has obtained all of the rights, licenses, and permissions in writing from each person (or from parent/legal guardian if person(s) in Video Essay Submission are considered minors in their state of residence) who appeared in or helped to create the Video Essay Submission. If

Sponsor determines in its sole discretion that an entrant has breached a representation or warranty, the entry will be disqualified.

Neither the Sponsor nor any of its respective affiliates and each of their respective officers, directors, volunteers, agents and employees, nor any Internet access providers (collectively "Released Parties") are responsible for incorrect or inaccurate entry of information, human error, technical malfunction, lost/delayed data transmission, omission, interruption, deletion, defect, line failure of any telephone, computer or other network, computer equipment, software or any combination thereof, from problems uploading or downloading any materials from a web site, or for late, lost, damaged, misdirected, incorrect or incomplete entry. For purposes of these Official Rules, receipt of entry occurs when Sponsor successfully receives the video file and all required entry documents and information.

**Judging to Determine Finalists and Alternates:** All eligible Entries received during the Video Submission Period will be judged by a panel of representatives of the Sponsor ("Panel"). The Panel will score each eligible entrant's Video Submission based on the following judging criteria, each given equal weight:

- Creativity and originality including use of required elements
- Quality of the information provided
- How well the Video submission exemplifies the actual biomedical research
- The power of the work
- Overall impression

The judges' decisions are final and binding in all matters relating to this Contest.

**Video Essay Posting For Fan Favorite Voting:** All Video Essays meeting the requirements of these Rules as determined by Sponsor shall be posted for public voting to determine the Fan Favorite Winner in each grade category at <https://tinyurl.com/Celebrate-Mouse-Entries> During the Voting Period persons may vote a maximum of once. Public voting shall be either "Thumbs Up" or "Thumbs Down". Subsequent votes by a individual will be disqualified. At the conclusion of the Voting Period the votes will be tabulated. The top ranked finalist in each grade category will be deemed the Fan Favorite Video. In the event of a tie, all tied entries will be re-judged by an additional judge selected by Sponsor, who, using the judging criteria will break the tie. The judges' decisions are final and binding in all matters relating to this Contest. The Fan Favorite Prize Winners will be announced at <http://kids4research.org/fun-stuff/Celebrate-the-Mouse-Video-Essay-Contest> on or about January 31, 2018.

**Winner Notification:** The First, Second and Third Place winners in each grade category will be notified by e-mail, phone or by mail on or about January 31, 2018.

**Prizes: First Place Winner in each Grade Category will be awarded \$500.00, a First Place Certificate and \$500.00 will be donated to the Winner's registered school. Second Place Winner in each Grade Category will be awarded \$250.00, and a Second Place Certificate. Third Place Winner in each Grade Category One will be awarded \$100.00, and a Third Place Certificate. Fan Favorite Winner in each Grade Category One will be awarded \$100.00.** Airing of any video is at Sponsor's discretion. There is no retail or other value associated with airing or use of any Video All federal, state or other tax liabilities are the responsibility of the winner.

**Other Conditions:** All federal, state and local laws and regulations apply. Contest void where prohibited. Sponsor reserves the right, at its sole discretion, to cancel, terminate, modify or suspend this Contest or any portion hereof at any time for any or no reason, or to disqualify any individual implicated in any of

the following actions, if for any reason: (a) infection by computer virus, bugs, tampering, unauthorized intervention, actions by entrants, fraud, technical failures, or any other causes which, in Sponsor's opinion, corrupt or affect the administration, security, fairness, integrity or proper conduct of the Contest, (b) the Contest or any website associated therewith (or any portion thereof) becomes corrupted or does not allow the proper processing of entries per these rules, or (c) the Contest is otherwise not capable of running as planned. By entering, participants agree to release and hold harmless the Released Parties, from and against any and all claims, actions and/or liability for any violation of the Official Rules by participants (including any warranties made by participants), any injuries or death, loss or damage of any kind arising from or in connection with participation in and/or entry into the Contest. The Released Parties are not responsible or liable for any incorrect or inaccurate entry information, and assume no responsibility for (i) any error, omission, interruption, defect or delay in operation or transmission at any website, (ii) communications line, hardware and/or software failures, (iv) damage to any computer (software or hardware) resulting from participation in the Contest, (v) theft or destruction of, tampering with, unauthorized access to, or alteration of entries and/or entry information, or (vi) entries which are late, lost, stolen, damaged, illegible, unintelligible and/or postage due (or any combination thereof). The use of third-party software or website or automated entry systems to participate is prohibited, and Sponsor reserves the right to disqualify entries made in such fashion. By entering, entrants agree to comply with these rules. Any entrant who attempts to tamper with this Contest in any way shall be disqualified. In the event of dispute as to who submitted an online entry, the entry will be deemed submitted by the Authorized Account Holder of the e-mail address submitted at the time of entry.
